# OUR MISSION

The **Pennsylvania Coalition Against Domestic Violence (PCADV)** is a statewide collaborative membership organization committed to ending intimate partner violence and all forms of violence against women.

# ABOUT PCADV

PCADV administers the state contract for domestic violence services through the distribution of state and federal funds to its 60 community-based programs, and through implementation and monitoring of standards to meet the needs of victims. For over 40 years, our network of community programs has been providing direct service to victims 24-hours-a-day, 7-days-a-week.

Each year, nearly 90,000 victims and their children are served—more than 2.5 million since 1976. Concurrently, the statewide office has worked in partnership with members of the legislature, state agencies, and other allies to make victims of domestic violence and communities safer, and to hold offenders accountable.

Dear Colleagues,

At the close of 2016-17 fiscal year, I was navigating a lengthy recruitment process as a candidate for PCADV's Executive Director. Having been selected for the role, and on board since October 2017, I'm pleased to share the successes of the Coalition during the last year—many of which were accomplished during a period of transition. I'm even more excited by where we are now, and what's to come.

Last year was a productive one. Training allied partners has always been a cornerstone of our work. In 2017, our Program Services team expanded their training efforts. This included training 500 members of the Pennsylvania Auditor General's office on the impact of domestic violence in the workplace. Last year also marked the five-year anniversary of the Lethality Assessment Program in Pennsylvania, which connects high-risk victims to domestic violence services—14,000 victims have been screened in the last five years. Committed to responding to evolving technologies, our Prevention team launched the Coalition's first ever mobile application, *Raising Respect: Talking Teens and Healthy Relationships*. We also broadened our social media advocacy to advance prevention and awareness messaging. As always, PCADV remained focused on policy reform to improve safety for victims and survivors of domestic violence. With the help of Senator Tom Killion, domestic violence homicide prevention legislation was reintroduced in this legislative session and continues to see progress. These are some of the highlights of our work in 2017, and this report contains more details about our programs and activities.

Since joining PCADV, my mantra has been, "it's a new day." The Coalition is currently the strongest it's been. Many new faces fill positions here at the statewide office. We're a team of fresh talent energized by social justice, passionate about improving the lives of victims of domestic violence, and committed to restoring PCADV's position as the nation's premier Coalition. We're moving forward with tenacity, and an agenda of expert training, increased public awareness, engaged advocacy and progressive policy reform.

# PCADV FOCUSES ON TRAINING AS KEY TO DOMESTIC VIOLENCE ADVOCACY AND PREVENTION

---

Nearly every day, Coalition staff provides training and technical assistance on topics related to domestic violence. Staff regularly travels across the state to hold training sessions for a variety of audiences that include court personnel, law enforcement, and allied stakeholders. The training staff also works with our domestic violence programs across the state to maintain a trained and skilled network of domestic violence advocates and attorneys.

Our **Lethality Assessment Program (LAP)**, now in its fifth year, continued to connect victims with critical domestic violence services. In 2017, the number of partnering law enforcement agencies climbed to 265 – a remarkable leap from the 21 agencies that signed on in 2012. Additionally, LAP is now in 43 counties with 45 participating domestic violence service organizations.

Law enforcement responding to the scene of a domestic abuse situation can use the Lethality Assessment Program to ask victims a series of questions to determine if they are at high-risk of being killed by their intimate partner. Following the screening,

if they are considered to be high-risk, they are immediately put in touch with lifesaving domestic violence services.

Since the program began in 2012, more than 14,000 victims have been screened through the LAP.

In addition, in 2017, our staff trained nearly 500 members of the state Auditor General's office on the impact of domestic violence in the workplace. We also trained magisterial district judges on the link between animal abuse, child abuse, and domestic violence.

In addition, our victim services team held trainings on medical advocacy including sessions about victims with traumatic brain injuries, elder abuse and protective services, and economic justice. Trainings on economic justice included tools to get survivors back on their feet after suffering abuse, as well as sessions for County Assistance Office workers that demonstrated the nexus between poverty and domestic violence for service recipients.

## PCADV PRIMARY PREVENTION

---

## REGIONAL MEETINGS

---

Our Prevention Team traveled the state in 2017, bringing a variety of trainings and meetings to local prevention staff at our 60 member programs. Three times we toured the state with the **Rhode Island Coalition Against Domestic Violence (RICADV)** to train

on program planning and evaluation; twice we visited six different regions for in-person meetings; and once we brought in **Strategic Prevention Solutions** to each region for a live webinar (and free workbook) on evaluation strategies.



# RAISING RESPECT APP



This year, PCADV had the opportunity to turn years of work and evaluation into a tangible, downloadable mobile application for parents.

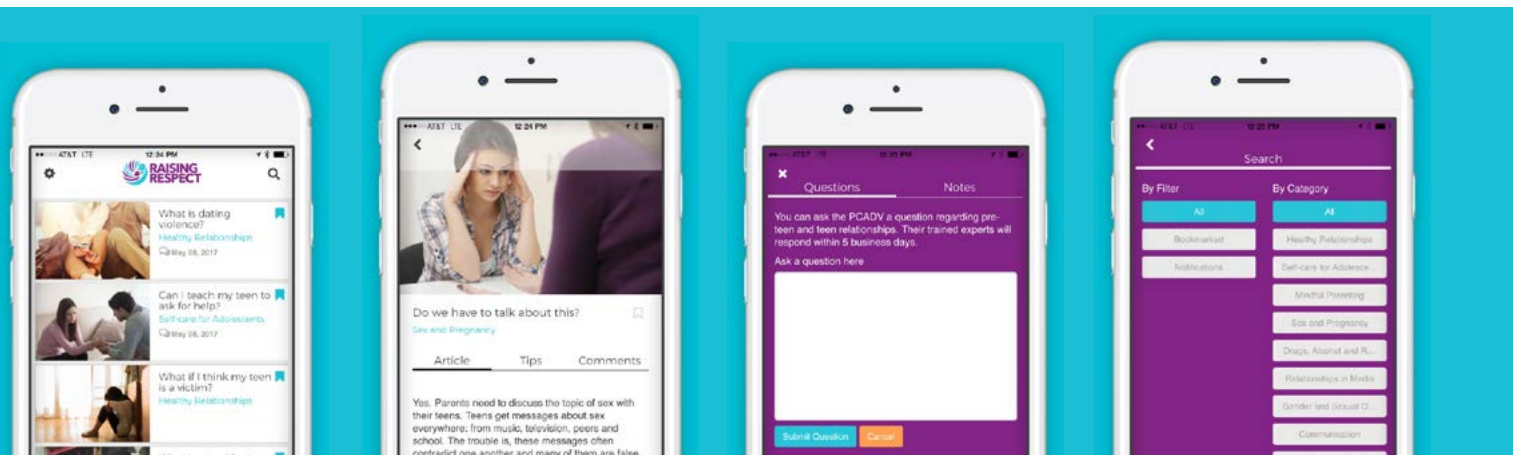
PCADV conducted focus groups and statewide surveys of parents to collect feedback on the user experience of the application. After analyzing the responses from each evaluation, we began building our app.

The **Raising Respect** app, available for free download on both Apple and Android devices, covers topics such as:

- Healthy Relationships
- Mindful Parenting
- Sex and Pregnancy
- Drugs, Alcohol, and Relationships
- Relationships in Media
- Gender and Sexual Orientation
- Communication
- Social Media and Smartphones
- Self-care for Parents
- Self-care for Adolescents

The app includes articles written by professionals in the field of domestic violence and prevention and includes tips on how to approach conversations with teens on relevant topics. App users can choose to be notified when new articles are published in the app.

*The app is designed to encourage parents to begin conversations with their children before they start dating and forming relationships outside the home, and to help parents navigate difficult topics.*

## COACHING BOYS INTO MEN

Thanks to a generous grant from the Wawa Foundation, we were able to implement the **Coaching Boys Into Men (CBIM)** program in the Eastern region.

In November, twenty advocates, representing 11 programs, received a full-day training facilitated by **Futures Without Violence (FWV)** and an advocate from **Pittsburgh Action Against Rape** with several years' experience of CBIM implementation. Eight programs participated for the full implementation with coaches and athletes from November through June. Programs received funding to bring CBIM to their communities, and PCADV provided training, tool kits, and coaching incentives.

FWV also facilitated a Booster Session halfway through the project to discuss progress, barriers and potential solutions.

Sixty-four coaches and athletic directors received training from program advocates and 132 male athletes participated in CBIM.

Advocates, representing seven programs attended a meeting in June to capture successes, lessons learned and ideas for continued expansion. Advocates reported that CBIM opened new doors within their communities. Many were energized by the enthusiasm for CBIM shown by coaches and athletes. Most programs plan to continue training high school coaches in the fall sports season, while others are engaging sports teams at the community level.

# PCADV EXPANDS GRASS ROOTS NETWORK THROUGH SOCIAL MEDIA

*PCADV is committed to listening, engaging, and building relationships with media—both traditional and social—to raise awareness of PCADV's mission and priorities.*

The Coalition was featured in television and newspaper stories throughout the year. Coverage highlights included Domestic Violence Awareness Month in October 2016; PCADV's 40th Anniversary Conference with keynote speaker Gloria Steinem; Teen Dating Violence Awareness Month in February 2017; the unveiling of domestic violence prevention legislation in March 2017; and the Father's Day Pledge to End Domestic Violence in May-June 2017.

PCADV continued to expand its following on social media through Facebook, Twitter and YouTube. Instagram was added as our newest social platform.

In June, the Biden Foundation amplified messaging by promoting our Father's Day Pledge on Twitter. In the same month, Pennsylvania Gov. Tom Wolf posted a video to his Facebook page that urged men to sign the

pledge and directed them to PaSaysNoMore.com. The governor's video was liked by more than 1,100 Facebook fans and shared 180 times.

In April 2017, the *Pittsburgh Post-Gazette* published a story about the impact of Pennsylvania's new strangulation law, which made the act of strangulation a crime when the law took effect in December 2016. The article showed that 109 people had been charged in 112 strangulation cases in Allegheny County. PCADV was integral in drafting the legislation, which was signed by the governor in October 2016. Other news outlets also covered the importance of this law for victims of domestic violence.

# PCADV ADVANCES LEGISLATIVE PRIORITIES

PCADV's legislative agenda focuses on policy priorities that improve access to services for victims and survivors of domestic violence and their children as well as those that strive to make homes and communities safer.

Broadly, these focus areas include: **access to safe and affordable housing, economic justice, preserving access to resources for vulnerable populations, protecting funding for domestic violence services, and domestic violence homicide prevention.**

In this legislative session, PCADV has been active on a package of Senate bills (SB 449, SB 500, SB 501, SB 502) introduced in the spring of 2017, which all intended to strengthen PA's Protection from Abuse (PFA) Act. In the 2015-2016 legislative session, domestic violence homicide prevention legislation was introduced by Sen. Pat Vance. This session, Sen. Tom Killion (R-9) championed the legislation (SB 501) and the bill continues to garner legislative support and media interest.

The goal of this legislation is to protect victims by keeping guns out of the hands of abusers convicted of misdemeanor crimes of domestic violence.

**This legislation proposes to:**

- Narrow the window of time an offender has to turn over their guns for safekeeping to 48 hours. Current law allows 60 days—too much time for an offender to lethally use weapons against their victims.
- Make relinquishment of firearms, weapons and ammunition, mandatory for abusers subject to a final PFA.
- Eliminate the ability for offenders to turn guns over to friends or family members for safekeeping; instead weapons must be turned over to law enforcement, a licensed firearms dealer, or an attorney.
- Strive to improve the safety of victims of domestic violence, law enforcement and the community by keeping guns from abusers who have demonstrated a propensity for violence.

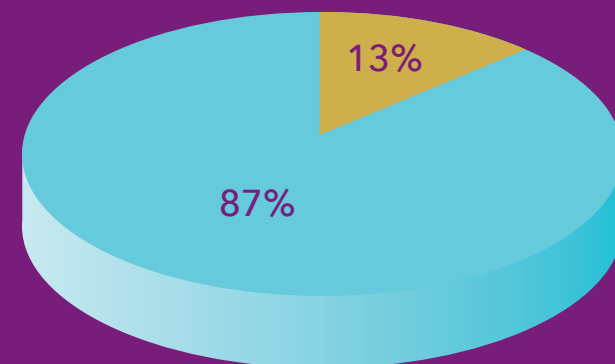

# DONOR SPOTLIGHT: FEDEX GROUND

Domestic violence isn't a private family matter, and it doesn't only happen inside homes. It's an epidemic that reaches far beyond the confines of a house.

FedEx Ground recognizes the impact domestic violence can have on employees and the community at-large, which is why it donates to the Pennsylvania Coalition Against Domestic Violence to help lead the charge against intimate partner violence.

"Domestic violence is a problem that affects more people than the public may realize, and in the workforce, it's a topic that many have considered taboo for too long," said Angela Wheland, FedEx Ground's vice president of communications.

Pittsburgh area-based FedEx Ground, a subsidiary of FedEx Corp., is featured in this year's donor spotlight for the impact it has made through its generous donations and education fund.

As a corporation, FedEx is committed to investing \$200 million in more than 200 communities worldwide by 2020 through its FedEx Cares initiative. The company's core giving areas include employment pathways and global entrepreneurship, among others.

The FedEx Ground Education Fund was established to support those who access domestic violence program services in Philadelphia, Delaware, Chester, Montgomery, Bucks, Lehigh, Berks, Northampton, Allegheny, Washington, Fayette, Greene, Westmoreland, Lawrence, Beaver, Butler, and Armstrong counties.

The fund is intended to help bridge the gap between obtaining a living wage job and accessing the education or certification necessary by providing needs-based scholarships to adults of up to \$1,000. The scholarships can cover costs such as tuition, application fees, books, licensing exam fees, supplies, computers, certification fees, etc., all of which aid domestic violence survivors in meeting job requirements. The goal is for the program to lead to long-term economic stability for survivors.

"What we love about the education fund is our ability to directly and positively affect a real person with a real story," Angela said. "The intention of the fund is to help domestic violence survivors take a step in the right direction. It's about making a lasting difference."
